





Which Safety Solution Is Right For Your Agency: SEM or RISC?

Each approach offers distinct advantages, and the choice between them hinges on your agency's operational priorities, technological landscape, and long-term safety and asset management goals. Based on our experience working with agencies our guidance is:

- Safety Event Management (SEM) is perfect for smaller agencies or agencies where only one or two user types are involved in the incident workflow
- Risk, Incident & Safety Compliance (RISC) is recommended for larger agencies with more complex data structures, when the agency wants to centralize incident management across the organization into a single source of truth, or when the Safety team wishes to utilize the audit, corrective action, or hazard management functionality available within RISC.
